## **TERMS AND CONDITIONS OF SALE & LIMITED WARRANTY**

All goods sold by Engineered Specialties, LLC ("Seller") to any customer ("Buyer") shall be governed by all the following Terms and Conditions, including the attached Limited Warranty. Buyer's order for any goods from Engineered Specialties, LLC, (Seller) shall constitute acceptance of these Terms and Conditions and Limited Warranty, without any reservation.

- Terms and Conditions of Sale: All descriptions, warranties, quotations, offers, acceptances and sales of
  the Seller's products are subject to and shall be governed exclusively by the terms and conditions stated
  herein.
- 2) Payment: Standard terms of net 30 days will be allowed for all established accounts. Amounts not timely paid shall bear interest at rate or the one and one half percent (1½%) per month (or 18% per year) that the Buyer is late in making payment. For Sellers without established terms, multiple payment methods or money sources, Seller reserves the right to use the Buyer's credit card on file to pay off remaining balances that are overdue. All other transactions shall be made in the form of a credit card sale or pre-payment via check or bank transfer.
- 3) **Order Cancellations**: Once you've placed an order with us, you may be able to cancel it without penalty, depending on its progress. If you would like to cancel, contact us immediately. If you're paying by credit card/PayPal, there may be a 3% penalty charged to your credit card for cancellation. Once your order has been shipped/picked up, it is no longer possible to cancel your order (see "Returns").
